Research Paper Writing Workshop Report

Introduction:

The Research Paper Writing Workshop organized by IQAC of Navneet College featured Mr. Ahtesham Arif Shaikh, a seasoned faculty member and Coordinator of the IT Department at A.P. College. The session commenced with a warm welcome and introduction to the speaker's credentials, including an MBA and MCA degree and NET, SET qualifications.

Workshop Overview:

Mr. Shaikh initiated the session by posing the fundamental question, "What is a research paper?" He eloquently explained that a research paper goes beyond the mere compilation of information, emphasizing its role as an expanded essay presenting original research findings and interpretations. The analogy of a cricket player aiming for the world cup underscored the importance of a positive attitude and self-belief in achieving excellence in research paper writing.

The workshop outlined four key stages in research paper writing: choosing a topic, conducting research, creating an outline, and the actual writing process. Mr. Shaikh elucidated that a standard research paper typically comprises ten sections, including abstract, introduction, review of literature, objectives, methodology, research analysis, results, recommendations, conclusions, and references.

He emphasized the significance of defining the study area and objectives, narrowing down the research focus. This involved providing details on the location, geology, climate, and a map of the study area. Objectives were illustrated with examples, linking them directly to the purpose of the research. The workshop delved into the methodology section, distinguishing between primary and secondary research methods. Additionally, the results or findings section was explored, emphasizing the importance of summarizing research matter concisely.

Mr. Shaikh provided detailed insights into literature review and gap analysis, crucial components of research paper writing. Students were encouraged to think critically about these aspects, fostering a deeper understanding of the research landscape. After approximately three hours, students actively engaged in preparing abstracts and methodologies for their respective research papers. Mr. Shaikh appreciated the students' enthusiasm and involvement in the program.

Conclusion and Vote of Thanks:

The workshop concluded with a section on drawing conclusions and a restated thesis statement. Mr. Satyendra Pal, HOD of the IT department, Navneet College, expressed gratitude to the students, the speaker, and the college management for their active participation and support in organizing the session.

Outcome:

The Research Paper Writing Workshop proved to be highly beneficial for M. Sc.IT and M. Com students, providing them with valuable insights and practical guidance for their research endeavors.
